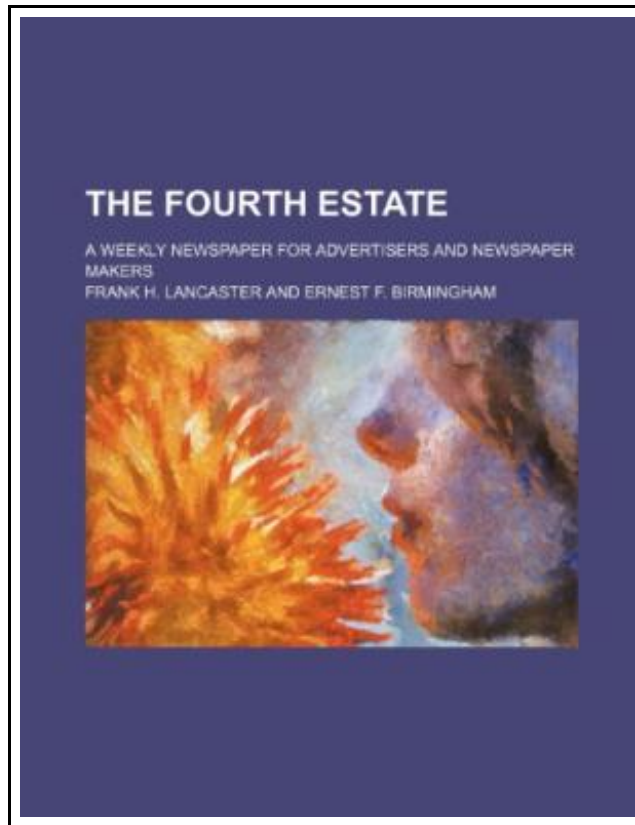

Henry Esser, corporation counsel for Mount Vernon, N. Y., for a change of venue in the action brought by the Star Company, publisher of the Hearst newspapers, to restrain the officials of Mount Vernon from enforcing an ordinance for the issuance of licenses to newsdealers. On the application of the Hearst newspapers Justice Donnelly issued an injunction against the Mount Vernon officials which will remain in effect until the matter can be tried or another court vacates the restraining order.
